## CLASSES OF MEMBERS

<b>CLASS OF MEMBERSHIP</b>	<b>REQUIREMENT</b>
<b>FOUNDER MEMBERS</b>	Persons associated with the founding of the Society and who are signatories to Memorandum of Association
<b>ORDINARY MEMBERS</b>	Persons admitted to the membership of Society by the respective Branch of the Society by the Governing Council and who have paid admission fee of Rs. 3000.
<b>HONORARY MEMBERS</b>	Persons of eminence and distinction in various fields, in particular, but not restricted to medicine, social work or education. This membership is by invitation only and on the recommendation of Governing Council of Branch and confirmation by National Board.
<b>DONOR MEMBERS</b>	Persons who have gifted to Society immovable or movable property of such value as is determined by the National Board to render them eligible for such membership, as also persons who have paid to the Society a sum of Rs. 10,000 or more.
<b>PATRONS</b>	Persons who have paid to the Society a sum of Rs. 25000 or more.
<b>INSTITUTIONAL MEMBERS</b>	Firms, companies, organizations, societies or other associations of persons who have made contributions, in cash or kind, of such sum as is determined by the National Board
<b>ASSOCIATE MEMBERS</b>	Parents or guardians of residents, past or present of the institutions or facilities run by the Society who have paid to the Society a sum of Rs. 1000 or more.
